



DECISION N°2 MODIFYING THE FERI-AD-FERE FEE SCHEDULE

In view of law N°08/007 of July 07, 2008, on general provisions applicable to public establishments.

Considering the Decree n°09/63 of December 03, 2009, fixing the statutes of a public establishment named Multimodal Freight Management Office "OGEFREM" especially in its article 10.

Considering the need to implement Article 19 of the interministerial Order N°008/ CAB/ VPM/ MIN/ TC/ 2019, N°002/ CAB/ MIN/ - ECONAT-JKN/ 2019, N°63/ CAB/ MIN.ETAT/ COMEXT/ 2019 and N°001/ CAB/ - MIN/ FINANCES/ 2019 of January 22, 2019, on the compulsory subscription of the Electronic Import Information Form, the Certificate of Destination as well as the Electronic Export Information Form;

Having regard to interministerial Order N°035/ CAB/ MIN/ FINANCES/ 2016 and N°005/ CAB/ MIN-COM/ 2016 of March 23, 2016 on the Manual of Harmonized Procedures applicable to the Single Counter of Foreign Trade;

Considering the letter of His Excellency the Prime Minister N°CAB/ PM/ SEC/ PM/ tg/ 2019/ 0733 of May 06, 2019, relating to the execution of the instructions of the President on the taking of all necessary measures aimed at reinforcing the compulsory character of the subscription of the covering documents forming part of the documentary package required during the clearance operations, namely the FERI, the AD and the FERE.

The Director General of OGEFREM, decides:

Section 1: The tariffs FERI (Electronic Import Information Form), AD (Certificate of Destination), FERE (Electronic Export Information Form)
